REQUEST FOR QUALIFICATIONS (RFQ) – DESIGN (OPEN-END)**

Pursuant to §41-4-133 of the Code of Alabama, 1975, as amended, The Armory Commission of Alabama requests qualifications from qualified Architectural/Engineering (A/E) firms to provide professional design services for the renovation, repairs, and minor construction at various National Guard facilities throughout the State of Alabama and Armory Commission Property at Eglin Air Force Base, Florida.

Proposed Scope of Work: The scope of work involves the design and construction administration for the sustainment, revitalization, and modernization at Alabama Army National Guard Readiness Centers, Surface and Aviation Maintenance Facilities, and Alabama Army National Guard Training Centers. Environmental services may also be provided for the various facilities under this proposal. Typical projects and budgets include: Renovations/Restorations (\$250,000 to \$6,000,000), Metal Building Construction (\$100,000 to \$850,000), Site Improvements (\$100,000 to \$1,000,000), Shell Repairs (\$150,000 to \$850,000), Energy Conservation Improvements (\$100,000 to \$925,000), and Access Control Systems (\$25,000 to \$150,000).

The types of funding include state, federal, or a combination of state/federal funds received through Cooperative Agreements.

The term of the agreement will be an *Open-End Agreement*. The design services will be contracted under fee rates in accordance with the National Guard Bureau Uniform Standards for Payment of Architect-Engineering Services Fee Schedule which can be located at <https://smd.alabama.gov/architect-engineer-ae-solicitations/ae-solicitations/>.

Qualifications: A/E teams should be multi-disciplined and capable of complete project design. Successful firms shall be capable of managing multiple projects simultaneously. All firms shall have a permanent office located within the State of Alabama. The Applicants and any consultants shall hold current professional licenses and be registered in the State of Alabama.

Minimum Code of Alabama Requirements (current Code of Alabama available at <https://alison.legislature.state.al.us/code-of-alabama/>):

§41-16-82 of the Code of Alabama, 1975, as amended requires a disclosure statement to be completed and filed with all qualifications, proposals, bids, contracts, or grant proposals submitted to the State of Alabama in excess of \$5,000.00.

§31-13-1, et seq. of the Code of Alabama, 1975, as amended (Alabama Immigration Law) imposes conditions on the award of state contracts. Firms must agree to fully comply with the Immigration Reform and Control Act of 1986, as amended by the

Immigration Act of 1990, and the Beason-Hammon Alabama Taxpayer and Citizen Protection Act. Architects and engineers should review and adhere to these guidelines as appropriate to their project type.

§41-16-5 of the Code of Alabama, 1975, as amended imposes conditions on the award of state contracts. The firm must certify that it is not currently engaged in, and will not engage in, the boycott of a person or an entity based in or doing business with a jurisdiction with which this state can enjoy open trade.

§41-16-163 of the Code of Alabama, 1975, as amended requires the contracting parties affirm, for the duration of the agreement, that they are not currently engaged in, and will not engage in, economic boycotts.

Response: Interested professionals shall submit:

1. A letter of interest.
2. A statement of qualification utilizing GSA Standard Form 330 for the primary firm and all proposed consultants, information for similar relevant projects including the project description, project budget, scope of work, photographs (before and after), Owner's name and contact information, plus any other relevant information. Form 330 is available at <https://www.gsa.gov/forms>.
3. A completed Alabama Vendor Disclosure Statement. The form is available at <https://www.alabamaag.gov/forms-and-links/>.
4. Current selection criteria can be found in the State Military Department Regulation (SMDR) 200-3 (Dated 1 March 2025): *Architect/Engineer, Environmental Services, and Commissioning Agent Selection Board procedures*. Selection: RFQs will be reviewed by a preliminary selection board which will recommend the best qualified firms to compete on the Final Selection Board. The Final Selection Board process will be in an interview (question/answer) format. No more than six A/E firms will be selected for this open-end service.

Qualifications must be received no later than 4 p.m. on April 17, 2026.
